FEATURE	DESCRIPTION
VAT	<ul style="list-style-type: none">✓ Generate VAT ledgers (purchases and sales), automatically VAT protocols creation, custom declarations, monthly VAT and VIES declaration;✓ Export VAT and VIES files.
Intrastat	<ul style="list-style-type: none">✓ Precise Intrastat flows setup – Receipts, Shipments, Transfers;✓ Extract Intrastat transactions;✓ Manage them in Intrastat journals;✓ Export Intrastat declaration (regular, corrective) as xml-files.
Double Book Keeping (<i>Balance accounts</i>)	Keep detailed information in table ID 17 for the Balancing G/L account per each transaction. On this base some reports as General Ledger and Chronological journal report are developed.
Accounting reports	Get access to some major reports such as: <ul style="list-style-type: none">✓ General Account Ledger report;✓ Chronological journal report;✓ Trial Balance Register report;
Red Storno	Allows users to reverse G/L transactions with correct debit and credit position of the amounts in order not to generate an extra turnover to the G/L accounts.
Voiding	An option providing users easily to manage posted sales and purchase documents, their voiding and proper declaration in the appropriate VAT Ledgers according to the voiding date. Ability to print the voided document (all lines incl. / zero total amount).
Reporting	<ul style="list-style-type: none">✓ Print forms: Get printed layouts for sales posted documents: Invoice, Debit memo, Credit memo, Shipment, VAT Protocol...✓ Purchase and Sales Analysis by dimensions – option allowing users to display vendors/customers and locations as lines.
Fixed assets	<ul style="list-style-type: none">✓ Disposals – ability to set different G/L accounts per each different reason for Disposal (Sales / Scrap / Lack).✓ Depreciation plan - a local report of FA depreciation is developed in order to optimize reporting process.

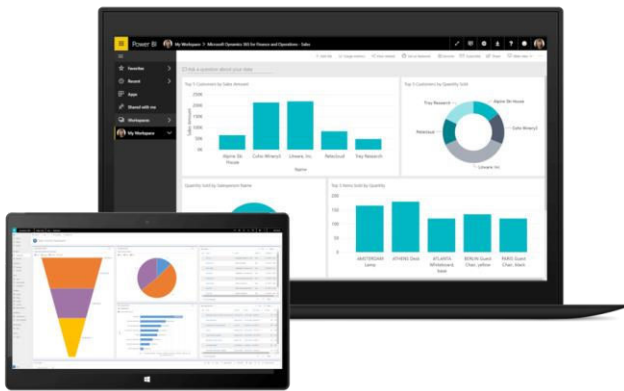
FEATURE	DESCRIPTION
Cash receipt printed layouts	Additional print layouts when users post payments either from Customers or to Vendors. <ul style="list-style-type: none">- Cash receipts – Payment Journal (receipts);- Cash withdrawals – Payment Journal (withdrawals).
Adjust Currency Exchange	Adjust exchange rate functionality with an option to be runed only per Bank Accounts, Customers and Vendors, as well as to be run in test-mode where the system displays amounts about to be posted.
Balance to Date reports	Improved reports “Customer – Balance to Date” and “Vendor – Balance to Date” enriched with additional information providing open documents not only in original, but also in the local currency.
Packaging Tax Calculation	Define package materials for items, collect data from their transactions and report package tax.
Account Schedule	Account Schedule Line Column Layout functionality will allow you to have different settings of the columns per each line.
Close Income Statement	Retained Earning Account per line in General Journal.
